

## ACP Rail's "Win Back Your Pass" Contest – Official Rules

### PURCHASE REQUIRED

#### 1. Eligibility

This promotion is open to individuals who are eighteen (18) years of age or older at the time of entry. Void where prohibited or restricted by law, including in the United Kingdom and the province of Quebec, Canada.

Employees of ACP Rail International, its parent company, affiliates, subsidiaries, advertising and promotion agencies, and their immediate family members (spouse, parent, child, sibling) or those living in the same household are not eligible.

To claim the prize, participants must possess a valid passport and meet any applicable visa requirements for travel. Failure to meet these requirements will result in disqualification.

#### 2. Sponsor

The Sponsor of this promotion is ACP Rail International, a division of ACP Marketing Canada Inc., located at 8375 Rue Bougainville, Suite 100, Montreal, Quebec, Canada H4P 2G5.

#### 3. Promotion Period

The contest begins at 12:00 AM EST on **June 9, 2025**, and ends at 11:59 PM EST on **July 6, 2025** (the "Promotion Period").

#### 4. How to Enter

To enter the contest:

- **Purchase a BritRail Pass** through ACP Rail International (ACPRail.com or UKRailpass.com only).
- **Travel in the UK** using your BritRail Pass during the Promotion Period.
- Tag ACP Rail International on **Instagram** (@acprail\_intl) or **Facebook** (@ACPRail) in a photo from your trip.

Additional entry details:

- Limit **one (1) entry per person per day**.
- Only BritRail passes purchased through **ACP Rail International** are eligible. Child and Saver passes not eligible.
- Participants must use their own social media accounts; entries made using multiple accounts, identities, or automated methods will be disqualified.
- The winner will be selected by **random draw** from all eligible entries.

By participating, entrants agree to abide by these Official Rules and all decisions of the Sponsor, which are final and binding.

## 5. Grand Prize Draw

One winner will be randomly selected from all eligible entries on **Monday, July 7, 2025, at 10:00 AM EST** ("Date of Draw").

## 6. Notification and Prize Claim Requirements

- The winner will be notified through the social media platform used to enter.
- If the winner cannot be contacted within **96 hours**, fails to meet eligibility requirements, or declines the prize, an alternate winner may be selected.
- The winner must:
  - Correctly answer a **skill-testing question**
  - Submit a valid passport copy
  - Complete, sign, and return a **Publicity Release and Prize Acceptance Form** within 20 days of the Date of Draw

Failure to comply will result in forfeiture of the prize.

## 7. Prize Details

The winner will receive a **refund of the purchase price** of their BritRail Pass, up to a maximum of **\$1,330 USD**, subject to verification.

Only passes purchased through ACP Rail International are eligible for refund. Proof of purchase is required.

## 8. Prize Exclusions

The prize does **not** include:

- Seat reservations or supplements not covered by the BritRail Pass
- Taxes, passport/visa fees, or vaccination costs
- Airfare, airport transfers, train station transfers, or parking
- Pass Protection or Insurance (travel, health, or cancellation)
- Excursions, meals, gratuities, and incidental or personal expenses

All additional costs are the sole responsibility of the winner.

## 9. Publicity Consent

By accepting the prize, the winner grants ACP Rail International the right to use their name, city/province/country, likeness, biographical information, and photo/video content from their entry in promotional materials, without additional compensation, unless prohibited by law

## **10. General Conditions**

- Sponsor reserves the right to cancel, modify, or suspend the contest at its discretion.
- The Sponsor is not responsible for lost, late, misdirected, or corrupted entries.
- The prize must be accepted as awarded; no substitution, cash alternative, or transfer is permitted.

By participating, entrants release the Sponsor and all affiliated parties (“Released Parties”) from liability related to participation, travel, injury, loss, or misuse of the prize. This includes any claims related to publicity rights, defamation, or privacy.

## **12. Governing Law**

This contest is governed by the laws of the province of Quebec and the federal laws of Canada.

## **13. Privacy Policy**

Personal information collected from entrants will be used solely for:

- Administering the contest
  - Contacting the winner
  - Verifying eligibility
- Entrants who opt in may receive promotional communications from ACP Rail International. Personal data will be accessible only to personnel involved in contest administration and will not be sold or shared with third parties.
